Position Open: Bulk Production Line Operator

Description: General duties include those of line operator, sealer,

boxer, bag filler and off-bearer to the conveyor. All employees are required to be in full uniform to include bouffant cap, beard cover (as applicable), and gloves. Hearing protection is recommended and safety glasses are required at all bag filling stations.

Employees will rotate from station to station on a scheduled basis in the interest of creating an ergonomically-friendly work environment.

Specific duties include filling gallon ice cream bags from the Speedy filler and transferring those bags to the adjacent bag sealing station. Employees at the sealing station will place the open bags into the sealer and they will proceed through the sealer to ensure the bags are properly sealed. Once sealed, the bags are placed into the case, six gallon bags to the case, and the employee at the boxing station will process the case through the box sealer. Once this step is completed, the employee at the off-bearing station will place the case onto the conveyor where it proceeds to the stacking hall.

All employees are required to attend weekly safety meetings and will receive Good Manufacturing Practices (GMP) training specific to their job function as per the HACCP/GMP Manual.

Employees should be in good general physical condition and able to stand for prolonged periods, bend, turn, twist and lift up to a minimum of 40 pounds, without restriction. Employees must work well with others and have good social and communication skills and be willing to take direction.

Description: The Future Physicians program gives undergraduate pre-medicine students a look into medicine, hoping to inspire them to pursue this rewarding field. Future Physicians participants will observe the preceptor performing patient care. They may also assist in performing non-invasive tasks when directly supervised by the preceptor. Participants may not administer medications, document in the medical record, or function as a sitter/companion.

After successfully completing the program, each participant will receive a \$500 Lisa Lasher Future Physicians Scholarship.

Minimum requirements to apply:

- Be at least 18 years of age
- Have a high school diploma or GED
- Be currently enrolled in an undergraduate program with a concentrated focus on pre-medicine. Preference will be given to students that have completed at least 2 years, however all applications will be accepted and reviewed.
- Maintain a 3.5 GPA will need a copy of current transcript from university
- Provide proof of COVID Vaccination OR be willing to receive COVID Vaccination at Mercy Health

- Must be available for orientation on June 8, 2021.

Position Open: Summer 2021 AmeriCorps Service

Position - Home Repair Coordinator

Type: Full-time Temporary, 450-hour position

Number of open positions: 1

Description: Three-month commitment as AmeriCorps Service Member beginning by early May 2021, and running through July 31, 2021. (A follow-up full year of service at the site, with additional benefits, is possible.)

The Midtown Alliance of Neighbors is one of several service sites across Kentucky partnering with the Homeless and Housing Coalition of Kentucky in their Homes for All program. This program is one of many AmeriCorps programs across the country.



The service position offers a living allowance of \$3,790 and an education award of \$1,678.57 upon completion of the required 450 hours of service (can be used for past or future educational costs). Student loans are deferred during the service period.

QUALIFICATIONS

- Thorough and organized with strong orientation to detail.
- Ability to work as a member of a team, meet deadlines, and plan work.
- Strong aptitude and some hands-on experience in construction is helpful.
- Excellent communication skills, with ability to communicate with community-based volunteers, youth volunteers, halfway house inmate community service workers, and low- and moderate-income homeowner clients; and to speak to groups to recruit and lead volunteers. Should be comfortable with telephone, mail, email, Facebook, website, and public speaking as modes of communication.
- Ability to effectively motivate and train volunteers to participate in construction activities.
- Ability to create and edit documents in Microsoft Word and Excel.
- Commitment to AmeriCorps and its policies and philosophies and to the non-profit's work toward eliminating substandard housing

RESPONSIBILITIES

The Rehabilitation/Construction Coordinator will assist with the following activities:

(1) Coordinate volunteer-led work events, helping approximately 3-5 homeowners. (Duties related to this program will take approximately 70% of the member's time.)

Work will include all aspects of the event--review of applications, visits to identify and prioritize work, outreach and recruitment of volunteers, pricing and purchase of materials as needed, coordination of work to be done, hands-on work as experience permits, tracking of expenses, and completion of all related paperwork.

- (2) Assist in coordinating moderate life and health-safety repairs at low-income homeowners' homes. (Duties related to this program will take approximately 20% of the member's time.)
 - Work with staff and homeowner to define scope of work. Aid in procurement of contractor(s).
 - Assist in working with contractors, and supervise volunteer work crews in completing additional work.
 - As directed, take responsibility for recordkeeping associated with each project, which may include client intake, final income and ownership verification, preparation of drawings or development of scope of work, procurement of contractors, agreements and contracts with clients and contractors, scheduling of inspections with the granting agency, tracking of expenditures, and all other required documentation.



- (3) Other Duties Related to the Homes for All Program (Approximately 10% of the member's total time will be spent on these activities).
 - Member will participate in remaining Homes for all Corps trainings.
 - Member will complete necessary Homes for All paperwork and reporting.

Minimum requirements to apply: At least 18 years old, ability to pass a background check, and driver's license and good driving record.
